Residential Homeowner Quoting System (RHQ)

- I. Broker agrees to make available to Producer the Company's Residential Homeowner Quoting System (RHQ) for the purpose of quoting and binding qualified homeowner risks in the state of Missouri. Broker further agrees to offer training to Producer in the use of RHQ.
- II. Producer agrees to obtain the original of the required, signed application **prior to binding** and produce said original signed application within 10 days to Broker. Producer further understands and agrees that no policy will be issued unless the payment coupon, along with the required payment is made payable and mailed to:

- III. Producer agrees to maintain all records pertaining to policies, binder, certificates, endorsements, notices or other material information concerning the insurance coverage provided for a period of five (5) years.
- IV. Producer will receive a commission of 15% (new business) and 10% (renewal) of premium paid by Geovera Service directly to the producer.
- V. Producer agrees to perform any due diligence required by State insurance laws or regulations in placing non-admitted insurance products and maintain copies of said requirements.
- VI. The RHQ System and files are considered to be proprietary and confidential to the Company, and the Producer agrees to take all reasonable measures to protect the Company's interests in the RHQ System and files. Producer further agrees that no advertisement or logo referring to the Company will be issued without the express written consent of the Company.
- VII. If required premium is not received within 30 days of the binder effective date, the binder will expire, and coverage will be cancelled flat effective at the inception date, without exception.
- VIII. Producer agrees to return any unearned commissions to broker upon request.

Midwest Earthquake Quoter (MEQ)

- I. *Broker agrees to make available to Producer the Company's Midwest Earthquake Quoter (MEQ) for the purpose of quoting qualified homeowner risks in the state of Missouri. Broker further agrees to offer training to Producer in the use of MEQ.*
- II. *Producer agrees to obtain the original signed application and to forward said application to the Company with the binder request. Producer also agrees to forward a copy of application within 5 days to Broker. Producer further understands and agrees that requested inception date will be honored only if Geovera Specialty receives full payment of premium along with payment coupon and signed application within 5 days of binder request. - IV. *Producer will receive a commission of 8% (new business and renewal) of premium paid by Geovera Service directly to the producer.*
- V. *Producer agrees to perform any due diligence required by State insurance laws or regulations in placing non-admitted insurance products and maintain copies of said requirements.*
- VI. *The MEQ System and files are considered to be proprietary and confidential to the Company, and the Producer agrees to take all reasonable measures to protect the Company's interests in the MEQ System and files. Producer further agrees that no advertisement or logo referring to the Company will be issued without the express written consent of the Company.*
- VII. *If required premium is not received after 5 days of the requested binder effective date, coverage will become effective at 12:01am the day after payment is received by Geovera Specialty.*
- VIII. *Producer agrees to return any unearned commissions to broker upon request.*
